Warrant for Annual Town Meeting, March 4, 1901 – File 13 No.

1

Essex SS: - To Amos G. Jones, one of the Constables of the Town of Methuen, in said County,

Greeting: -

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of the Town of Methuen, qualified to vote in elections and Town affairs to meet and assemble at the designated polling places of Precincts One and Two, namely: -

The Town Hall in voting Precinct One, and
The Basement of the Arlington School House in Voting Precinct Two, on Monday, the fourth (4) day of March next, at six (6) o'clock in the forenoon, to bring in to the election officers their votes for Town Clerk, Treasurer, Collector of Taxes, Selectmen, Assessors, Overseers of the Poor, Highway Surveyor, one School Committee man to serve three (3) years in place of Edward A. Bower, one Water Commissioner to serve three (3) years in place of George A. Smith, one Trustee of Nevins Memorial to serve two (2) years in place of Lewis E. Barnes, one Tree Warden to serve one (1) year, Constables, Auditor, Fence Viewers, and "Yes" or "No" in answer to the question, "Shall license be granted for the sale of intoxicating liquors in this Town?" All to be voted for on one ballot. The polls may be closed at four (4) o'clock p.m.

Also to meet,

At the Town Hall in said Town on Saturday, the ninth (9) day of March next, at ten (10) o'clock in the forenoon, then and there to act on the following articles, viz.: -

- Article 1 To choose a Moderator to preside at said meeting.
- Article 2 To elect all Town Officers not required to be chosen by ballot.
- Article 3 To hear the Annual Report of the Selectmen and act thereon.
- Article 4 To raise such sums of money as may be necessary to defray Town charges for the ensuing year, and make appropriations for the same.
- Article 5 To determine the manner of collecting taxes the ensuing year, and act thereon as the Town may think proper.

Article 6 To see if the Town will authorize the Town Treasurer, with the approval of the Selectmen, to hire money in anticipation of taxes of the current municipal year, and to issue notes of the Town therefor.

Article 7 To see if the Town will vote to approve and accept the list of jurors prepared by the Selectmen for the ensuing year.

Article 8 To hear the report of Committees and act thereon.

Article 9 To determine what compensation the Town will grant the members of the Fire Department for their services the ensuing year.

Article 10 To determine the manner of appropriating the amount received from dog taxes, in accordance with Chapter 102, Section 107 of the Public Statutes.

Article 11 By request of Col. William B. Greene Post, No. 100 G.A.R. to see if the Town will vote to appropriate one hundred and fifty (150) dollars for the purpose of decorating the graves of our soldiers and sailors on Memorial Day, May 30, 1901, said money to be expended under the direction of the above Post.

Article 12 To determine what compensation the Town will grant the Tree Warden.

Article 13. To see if the Town will vote to make an appropriation for the sum paid the Highway Surveyor, instead of taking it out of the regular appropriation of the departments under his charge.

Article 14 By request of Mrs. David Nevins, to see if the Town will vote to give her permission to beautify and improve the sides of the highways on Broadway and Hampshire Street from junction of said streets to land of Fannie M. Dodge.

Article 15 By request of Mrs. Fannie M. Dodge and others to see if the Town will vote to macadamize Hampshire Street from Broadway to the residence of Mrs. Fannie M. Dodge, a distance of about 2100 feet, and appropriate fifteen hundred dollars for the same.

Article 16 By request of the committee on sidewalks to see if the Town will vote to accept Chapter 50

of the Public Statutes relating to sidewalks.

Article 17 By request of Jos. S. Howe, to see if the Town will vote to authorize some person to sign deeds for the redemption of land which has been taken by the Town for unpaid taxes.

Article 18 By request of James O. Parker to see if the Town will vote to discontinue Beacon Street and that part of Highland Street lying east of land of Lindsey W. Keyes.

Article 19 To see if the Town will vote to act in conjunction with the Boston & Maine Railroad in bridging over the tracks of said railroad at the junction of Lowell and Osgood Streets and continue the power granted the Selectmen at the last Annual Town Meeting in reference to the same and appropriate five hundred (\$500) dollars therefor.

Article 20 By request of the School Committee, to see if the Town will authorize and instruct the School Committee to procure plans, specifications and proposals for a two room addition to the West Side School building and for a suitable school structure at the site of the present Barker School and appropriate two hundred (\$200) dollars therefor. The Committee to report their recommendations to a future Town Meeting.

Article 21 By request of the School Committee, to see if the Town will authorize and instruct the Selectmen to convey, by deed of the Town, to Henry Arnold a strip of land about three feet wide extending from Merrill Street, adjoining his property, to within a certain distance of the Arlington School building, in exchange for a deed for a similar strip of land from Mr. Arnold's lot adjoining the school house land opposite the north end of the Arlington School, in accordance with agreement made, or to be made with Mr. Arnold by the School Committee, and appropriate such sum, if any, as may be required.

Article 22 To see what action the Town will take with regard to the construction of sewers during the present year.

Article 23 To see if the Town will vote to hire money for the construction of sewers and take such action thereon as the Town may think proper.

Article 24 By request of Guy W. Currier and others to see if the Town will vote to build sewers in Boston, Kendall, Vermont and Boylston Streets, a distance of about five thousand feet, and appropriate five thousand (\$5,000) dollars for the same.

Article 25 By request of William P. Morse and others, to see if the Town will vote to macadamize Lowell Street from Railroad Square to Elm Street and appropriate three thousand (\$3000) dollars for that purpose.

Article 26 By request of James E. Johnson and others, to see if the Town will vote to macadamize Annis Street and make an appropriation for the same.

Article 27 By request of German S. Phippen, to see if the Town will vote to change the name of Merrimack Street to Haverhill Road.

Article 28 To see if the Town will vote to change the name of Pine Street, from Salem line to junction of Pelham and Pine Streets to Hampshire road, and from said junction to Pelham line to Pelham Street.

Article 29 By request of Board of Fire Engineers, to see if the Town will vote to purchase a combination hook and ladder truck and make an appropriation for the same.

Article 30 By request of James O. Parker and others, to see if the Town will vote to appropriate three hundred (\$300.) dollars for public improvements in the Town of Methuen, the same to be expended under the direction of the Town Improvement Society and Tree Warden of the Town.

Article 31 By request of the Water Commissioners, to see if the Town will vote the sum of twenty five hundred and seventy three dollars and eighty five cents, (2573.85), being the amount of premium derived from the sale of Methuen Water Bonds, also the amount of three thousand dollars (\$3000.00) from the net proceeds of the works last year, both to be applied to the sinking fund.

Article 32 By request of Edwin J. Castle and others, to see if the Town will vote to set edge stones from a point near the old fire engine house on Lowell Street to Central Fire Station, a distance of about four hundred and twenty five (425) appropriate the sum of two hundred (200.) dollars for the same.

Article 33 By request of Moses G. Smith and others, to see if the Town will vote to macadamize Orchard Street from Barker corner to Lawrence line and appropriate three thousand (\$3000) dollars for the same.

Article 34 To see if the Town will vote to appoint a committee to make an investigation in regard to securing a suitable lot of land for a play stead for athlete games and report the next Annual Town Meeting.

Article 35 By request of Willard A. Bodwell and others, to see if the Town will vote to clean out and lower the culvert at the foot of the hill near the house of George M. Cole, and appropriate fifty (50) dollars for the same.

Article 36 To see if the Town will vote to accept the extension of Summer Street, as laid out by the Selectmen, from a point near the residence of Antoinette Davis, to a point about one hundred feet beyond the residence of Richard Irvin, a distance of about four hundred feet.

Article 37 To see if the Town will vote to appropriate one hundred (\$100) dollars for the purchase and setting of street bounds.

Article 38 By request of Jesse M. Rutter and others, to see if the Town will vote to widen the roadbed on the north side of Pleasant Street from a point near the house of Jesse M. Rutter east about three hundred feet, and appropriate fifty (50) dollars for the same.

Article 39 By request of James Robie and others, to see if the Town will vote to repair William Street, and appropriate two hundred and fifty (250) dollars for the same.

Article 40 By request of William C. Sleeper and others, to see if the Town will vote to macadamize Milk Street from Dr. McAllister's corner to Short Street, and appropriate three thousand (\$3000) dollars for the same.

Article 41 By request of John T. Dugdale and others, to see if the Town will vote to maintain an arc light at the corner of Oakland Avenue and Granite Street and appropriate seventy (70) dollars for the same.

Article 42 By request of Thomas L. Barstow and others, to see if the Town will vote to maintain an arc light near the junction of Berkeley and Arlington Streets and appropriate seventy (70) dollars for the same.

Article 43 To see if the Town will vote to maintain three incandescent electric lights to be located on Russ, King and Boston Streets, and appropriate fifty (50) dollars for the same.

Article 44 By request of Joseph E. Buswell, to see if the Town will vote to maintain one incandescent electric light on Prospect Street, near the house of John Breen, and appropriate eighteen (18) dollars for the same.

Article 45 By request of S. L. Holman and others, to see if the Town will vote to locate and maintain a Welsbach street light on William Street and appropriate twenty four (24) dollars for the same.

Article 46 By request of Philip R. Park and others, to see if the Town will vote to locate and maintain two Welsbach lights on Lowell Street between Oakland Avenue and Elm Street, and appropriate forty eight (48) dollars for the same.

Article 47 By request of Willard R. Whitney and others, to see if the Town will vote to locate and maintain six Welsbach lights on Pleasant Street, between land of C. H. Tenney and Marston's Corner, and appropriate one hundred and fifty (150) dollars for the same.

Article 48 To see if the Town will vote to reimburse Robert E. Banister the amount of taxes overpaid by him during the years from 1894 to 1900, the same to be charged to general abatements for 1901.

Article 49 To see if the Town will vote to build a fence around the lot of the Central Fire Station and appropriate two hundred (200) dollars for the same.

Article 50 To see if the Town will vote to build a sewer on Willow Street, from Lawrence Street to Lawrence line, a distance of about two hundred and fifty feet, and appropriate two hundred and fifty (250) dollars for the same.

Article 51 By request of Joseph E. Buswell and others, to see if the Town will vote to appoint a committee of five to take into consideration the present methods of conducting Town affairs, salaries of Town officers, etc. and suggest such changes as they think best for the interest of the Town, and report at the next annual Town meeting.

Article 52 By request of E. F. Johnson, to see if the Town will vote to change the name of Leafy Lane to Ditson Lane.

Article 53 By request of the Methuen Company, to see if the Town will vote to locate and maintain a Welsbach light at the corner of Osgood and River Streets and appropriate twenty four (24) dollars for the same.

And you are hereby directed to serve this warrant by posting up attested copies thereof at the Town House, and at each of the public meeting houses in said Town, eight (8) days at least before said meeting.

Hereof fail not and make due return of this warrant with your doings thereon, to the Town Clerk on or before the time of the meeting aforesaid.

Article 3 **Selectmen's Reports**

Article 4 **Appropriations**

Voted – to lay Article 4 on the table, the same to be in order as the first business after the recess.

Article 5

Collection of Taxes

Voted: - that taxes be collected the same as last year, and that on all taxes remaining unpaid after October first, interest shall be paid from that date to the time of payment at the rate of six per cent per annum.

Article 6

Temporary Loans

Voted by a unanimous vote, that for the purpose of procuring a temporary loan to and for the use of the Town of Methuen, in anticipation of the taxes of the present municipal year, the Town Treasurer is hereby authorized and directed to borrow from time to time, with the approval of the Board of Selectmen, a sum or sums not exceeding in the aggregate fifty thousand dollars, and to execute and deliver the note or notes of the Town therefore, payable within one year from the time the loan is made. Any debt or debts incurred by a loan or loans to the Town under this vote shall be paid from the said taxes of the present municipal year.

Article 7

Jury List

It was voted that the compensation of the Tree Warden be twenty five cents per hour. Within an hour, a motion was made to reconsider the vote, which was carried; and it was then voted to establish the compensation of Tree Warden at forty cents per hour.

Article 13 **Highway Surveyor Salary**

Voted: - to make an independent appropriation for the salary of Highway Surveyor, and that twelve hundred dollars be appropriated for that purpose said sum to include the use of the team.

Article 14 **Mrs. David Nevins**

Voted, to give Mrs. David Nevins permission to beautify and improve the sides of the highways on Broadway and Hampshire Street, from junction of said streets to land of Fannie M. Dodge. The vote was unanimous, and taken by a rising vote.

Article 15 **Macadam Hampshire St.**

Voted: - to macadamize Hampshire Street from Broadway to the residence of Mrs. Fannie M. Dodge, a distance of about 2100 feet, and appropriate fifteen hundred (\$1500) for that purpose. On motion of John H. George, it was voted to accept the offer of James Robie to furnish ledge for Macadam, and that when the Stone crushing machinery is moved, it be moved to the ledge given by Mr. Robie.

Voted, to macadamize Hampshire Street from the residence of Mrs. Fannie M. Dodge to the New Hampshire line, and appropriate one thousand dollars therefor.

Article 16 **Sidewalks**

When Article 16 was reached the Committee on Sidewalks made the following report.

The Committee appointed by the Town at its last annual meeting to consider and report upon some system of procedure which would secure to Methuen good sidewalks of a permanent kind, hereby submit the following report.

- 1) In view of the wish of a majority of voters, hitherto expressed, that a portion of the expense of such permanent sidewalks as the Town may build, be paid by the abutters, your committee recommends the acceptance by the Town at this meeting of so much of Chapter 50 of the Public Statutes as relates to the subject of sidewalks, whereby it will be possible

for the Town to assess and collect from the abutters, one half the cost of such permanent sidewalks as it may build, provided such assessment do not exceed 1% of the assessed valuation of the abutting estate.

2) We recommend that an appropriation of \$2000 - \$1000 for concrete and \$1000 for edgestones, be made at this meeting, to be expended as hereinafter provided, during the current year, exclusively for permanent sidewalks, of concrete edged with stone.

3) That in the location of such new sidewalks, reference be had to the public convenience, the most populous and frequented streets taking precedence, to those less used preference being given also to such locations as will afford continuous walks, wherever in the judgment of the committee this course would be advantageous to the Town.

4) That the work be done by contact under the direction of a committee of three to serve without pay; which committee shall be appointed by the Selectmen, and cooperate so far as may be practicable with the Town Improvement Society.

5) That, in locations where edgestones have already been placed at the Town's expense, and no concrete walk, or a walk which in the judgment of the Committee is equal or superior to concrete, has been built, the entire cost of the sidewalk exclusive of edgestones, shall be assessed upon the abutter.

Voted: - to accept the Report of the Committee.

Voted: - to accept Chapter 50 of the Public Statutes relating to sidewalks.

Voted: - to appropriate two thousand dollars (\$2000) for permanent sidewalks, said sum to be expended as recommended in the report of the Committee.

Selectmen appointed Daniel W. Tenney, David M. Prince & Robert Driver.

Article 17 **Tax Deeds**

Voted: - to authorize the Selectmen to sign deeds for the redemption of land which has been taken by the Town for unpaid taxes.

Article 18 **Beacon & Highland St.**

Voted: - to discontinue Beacon Street and that part of Highland Street where Charles H. Tenney is an abutter on both sides of said Street.

Article 19

Bridge over B. & M. R.R.

Voted: - to act in conjunction with the Boston & Maine Railroad in bridging over the tracks of said Railroad at the junction of Lowell and Osgood Streets, and continue the power granted the Selectmen at the last Annual Town Meeting in reference to the same, and appropriate five hundred (\$500) dollars therefor.

Article 20

New School Buildings

Voted: - that the School Committee be authorized and instructed to procure plans,

Specifications and proposals for any new school buildings that may be required the present year, to select sites for such buildings and to report their recommendation to a future Town meeting. The sum of two hundred dollars is hereby appropriated for plans and specifications. James O. Parker and J. Milton Tenney were added to the committee to carry out the above vote.

Article 21

Henry Arnold Land

Voted: - to authorize and instruct the Selectmen to convey, by deed of the Town, to Henry Arnold a strip of land about three feet wide extending from Merrill Street, adjoining his property to within a certain distance of the Arlington School building, in exchange for a deed for a similar strip of land from Mr. Arnold's lot adjoining the school house land opposite the north end of the Arlington School, in accordance with agreement made or to be made with Mr. Arnold by the School Committee and appropriate such sum, as may be required.

Article 22

Voted: - to appropriate thirty thousand dollars for the construction of sewers the present year.

Article 23

Money for Sewers

Voted: - by a unanimous vote, that for the purpose of paying for the construction of sewers, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen, the sum of thirty thousand dollars and to execute and deliver the note or notes of the Town therefor payable in ten years from the date of issue, with interest thereon at the rate of four per cent per annum payable semiannually.

Voted: - to instruct the committee to ascertain if a contract exists between Methuen and Lawrence for the disposal of the sewage from Methuen Village.

Article 25 Lowell St.

A motion to macadamize Lowell Street was lost.

Article 26 Annis Street

Voted: - to macadamize Annis Street and appropriate fourteen hundred dollars for that purpose.

Article 27 Merrimack St.

The Town refused to change the name of Merrimack Street to Haverhill Road.

Article 28 Pine Street

Voted: - to change the name of Pine Street from Salem line to the junction of Pelham and Pine Streets, to Hampshire Road and from said junction to Pelham line, to Pelham Street.

Article 29 Hook & Ladder Truck

Voted that the sum of fifteen hundred dollars be appropriated to purchase a combination hook and ladder truck and that the truck be purchased.

Article 30 Public Improvements

Voted: - to appropriate three hundred dollars for public improvements in the Town of

Methuen, the same to be expended under the direction of the Town Improvement Society and Tree Warden of the Town.

Article 31 Sinking Fund

Voted: - that the sum of twenty five hundred and seventy three & 85/100 dollars being the amount of premium derived by the sale of Methuen Water Bonds, also the amount of three thousand dollars from the net proceeds of the works last year (\$5573.85) be applied to the sinking fund.

Article 32 Edgestones

Article 32 was referred to the Board of Selectmen.

Article 33 Orchard St.

Voted: - to macadamize Orchard Street from Barker Corner to Lawrence line, and appropriate three thousand dollars for that purpose; the money to be taken from the regular appropriation.

Article 34 Playstead

Voted: - that a Committee of five be appointed to make an investigation in regard to securing a suitable lot of land for a playstead for athletic games, and report at the next special Town meeting. Moderator appointed Guy W. Currier, Lewis E. Barnes, John T. Mannfield, Alfred Sagar and Frank McDermott.

Article 35 Culvert, Geo. M. Cole

Voted: - to clean out and lower the culvert at the foot of the hill near the house of George M. Cole, and appropriate fifty dollars for that purpose, to be taken from the regular appropriations.

Voted: - to build a sewer on Willow Street from Lawrence Street to Lawrence line, a distance of about two hundred and fifty feet, and appropriate two hundred and fifty dollars for that purpose.

Article 51 **Committee on Town Business**

Voted: - to appoint a committee of five to take into consideration the present methods of conducting Town affairs, salaries of Town Officers, etc., and suggest such changes as they think best for the interest of the Town, and report at the next Annual Town Meeting. Moderator appointed Joseph E. Buswell, Frank Remick, Alfred Newsholme, John D. Emerson and Wm. D. Hartshorne.

Article 52 **Leafy Lane**

Voted: - to change the name of Leafy Lane to Ditson Place.

Voted: - that when an excess of water is found to be taken the consumer so using it shall be immediately notified.

At ten minutes past five, all articles in the warrant being disposed of, the meeting voted to adjourn without delay.

Building Committee

Death of President McKinley

On the sixth day of September 1901, late in the afternoon, the people of Methuen were startled by the report that President McKinley had been shot by an assassin at Buffalo, where he had gone to attend the Pan American exhibition. The news was received with incredulity at first, and excited the whole Town. The next morning, the reports of his condition were more favorable, and continued to be so, for several days. On Thursday morning the report was received, that his physicians pronounced him as practically out of danger, and the excitement over the attempted assassination began to subside. On Friday morning news came that he had taken a sudden turn for the worse, and the reports became more and more unfavorable, through the day. Between three and four o'clock on Saturday morning, the tolling of the bell on the engine house announced to the towns people that the President was dead. The shock to the community was very great. On Saturday

Parker were appointed a committee to prepare suitable resolutions. Thursday, Sept. 19th, the day of the funeral at Canton, Ohio, was generally observed as a day of mourning throughout the country. In Methuen all places of business were closed through the day, and memorial services were held at Nevins Memorial Hall at two o'clock p.m. A procession was formed in the square near the Town Hall, headed by Wm. B. Greene Post 100 G.A.R. and followed by the Town Officers, speakers at the service, members of the D.A.R., High School Cadets and citizens, and proceeded without music to the Nevins Memorial Hall, where exercises were held as follows: -

Hon. Guy W. Currier, presiding.

Singing, - "Jesus Lover of my soul" by the congregation.

Scripture reading, 1 Corinthians 15-20-58 by Rev. W. R. Libby of the Universalist Church.

Prayer by Rev. Nathan Bailey, Pastor of the Baptist Church.

Singing: - "Abide with me, fast falls the eventide".

The following resolutions were then read by Joseph S. Howe of the Committee on Resolutions.

Whereas, The people of the Town of Methuen are assembled in this hour of universal grief that they may give formal expression to the deep sorrow which they one and all feel for the death of the Chief Magistrate of the United States, be it therefore

millions of people; beloved by his own country, and respected by all the nations
of the earth.

Resolved: - That we express to Mrs. McKinley, the wife of the President, for
whom his tender
solicitude has so endeared him to all, - our sympathy in her great bereavement.

Resolved: - That to the new President, Theodore Roosevelt, brought so suddenly
face to face with
stupendous responsibilities, we pledge our loyal support, in the full faith that the
vast power with
which this tragedy has invested him, will be wisely and conscientiously exercised,
to the continuing
credit and honor and prosperity of the nation.

Voted, that the sum in the Treasury received from the Street Railway Company (\$4302.93) be spent in repairs on macadam, and that the amount received from excise tax (\$1651.15) be expended on streets through which the street railway runs.

Article 5 **Collection of Taxes**

Voted: - That taxes be collected the same as last year, and that on all taxes remaining unpaid after October first, interest shall be paid from that date to the time of payment at the rate of six per cent per annum.

Article 6 **Temporary Loans**

Voted: - by a unanimous vote, that for the purpose of procuring a temporary loan, to and for the use of the Town of Methuen in anticipation of the taxes of the present municipal year, the Town Treasurer is hereby authorized and directed to borrow from time to time with the approval of the Board of Selectmen, a sum or sums not exceeding in the aggregate, sixty thousand dollars, and to execute and deliver the note or notes of the Town therefore, payable within one year from the time the loan is made. Any debt

or debts incurred by a loan or loans to the Town under this note shall be paid from the said taxes of the present municipal year.

Article 8

Report of Committees

The Committee appointed to examine and report on case of Ernest Gaunt presented the following report.

Committee on Case of Ernest Gaunt

“To the voters of the Town of Methuen,
 Gentlemen: - The Committee chosen at the last Town
 Meeting to make investigation concerning the accident in the High
 School, whereby Ernest Gaunt was injured, have endeavored to perform
 their duty with fidelity.

We visited the school laboratory and gained information separately from a number of pupils in the chemistry class who were present when it occurred. We believe the School Committee have intended to supply every appliance necessary for work there, and they, as well as all other right minded citizens, deplore the results of this occurrence. We ascertained that there was an ample supply of test tubes for all of the scholars in the class to make use of; they being of much larger size than the ignition tube selected by Ernest Gaunt and one or two others.

The teacher informed this committee that earlier in the season the class had been instructed against using these small tubes for experiments, except by permission, but at this time the class was in charge of a substitute teacher, and the two or three pupils, in a class of thirteen selecting these small ones had either forgotten previous instructions or disregarded them.

We think the textbook in use should be more specific in stating what size tubes to make use of for the experiments, as there is only one place in the

book where the size of tube for an experiment is given. Ignition tube is simply a general term, applicable to any size, as they may be one quarter inch bore or many times that size, and too much is left to the discretion of the instructor, or pupil performing the work.

The teacher in charge at the time this occurred stated that she three times cautioned the class about the quantity to use, and gave instructions about holding the tube while heating; and several of the pupils testified to the same.

It is the conviction of this Committee that the quantity used was not the factor that caused the explosion, but making use of a tube that was not adapted to such a test, and it is our opinion if the regular teacher had been present there would have been much less likelihood of this accident.

This Committee, by good authority, have ascertained that the Town is not legally liable for an accident of this kind but owing to the large expense Mr. Gaunt has been obliged to incur, (some six hundred dollars already, and to the fact that the young man will be obliged to wear an artificial eye, as well as have the occasional attendance of a physician, we feel that we can do no less than recommend a payment of fifteen hundred dollars.

It was voted to accept the report of the Committee and also that the thanks of the Town be tendered to the Committee for their services.

Article 22

Ernest Gaunt

On motion of Mr. C. W. Mann it was unanimously voted that the Town appropriate and pay to Henry Gaunt, father of Ernest H. Gaunt, a minor, the sum of twenty five hundred dollars for injuries while performing a chemical experiment in the High School.

Mr. Mann moved that the School Committee be instructed to discontinue the dangerous use of chemicals in the schools of Methuen. The motion was lost.

The Committee on new school house reported verbally that it is not advisable to attempt to build a new school house the present year, and their report was accepted.

The Committee appointed to consider changes in the methods of doing Town business, reported verbally by the Chairman Mr. Buswell, that their report had been printed, and that they desired that action thereon should be postponed to the adjourned meeting.

Report.

Report of the Committee appointed to take into consideration the present methods of conducting Town affairs, salaries of Town Officers, etc. and to recommend changes.

Your Committee appointed at the last annual Town meeting to take into consideration the present methods of conducting Town affairs, salaries of Town officials, etc. after careful investigation of the manner in which the Town's business is conducted in Methuen, and comparing it with other towns of a similar size in the state, believe that the interests of the citizens would be better served if a change were made in the Town offices. As is well known a large number of towns in this state elect separate boards of Selectmen, Assessors, Overseers of the Poor and Boards of Health, and of ten (10) towns, ranging from 7,061 to 8,263 inhabitants five (5) being next larger and five (5) next smaller than Methuen, only on Town (West Springfield) has the same officials serving as Selectmen, Assessors and Overseers of the Poor, and the same person serving as Town Treasurer, Town Clerk and Collector of Taxes, as is the case in Methuen.

With an increase of fifty (50) per cent in the valuation of this Town between 1890 and 1900, with the increasing amounts appropriated each succeeding year, with the addition of a Board of Health (created in 1896) and a corresponding increase in the other departments of the Town, your committee believe that the Selectmen, Assessors, Overseers of the Poor and Board of Health should be relieved from the burden of the routine work, which should be entrusted to a competent clerk, following the example of the School Department and Water Works.

Your Committee believe that as the duties of the Selectmen and Overseers of the Poor are not arduous, these two offices should be combined but that there should be a separate Board of Assessors and a separate Board of Health.

Anyone who has served as Selectman, Assessor, Overseer of the Poor and member of the Board of Health during the past few years and is familiar with the multitudinous duties which have devolved upon him cannot fail to see that a division of offices, as proposed, must naturally result in a more satisfactory transaction of the Town's business.

Of the necessity of a Board of Assessors devoting their undivided attention to that department and a Board of Health unhampered by other offices, the citizens are well aware.

We believe the acceptance of the statute allowing the Town to elect a Town Clerk, who shall serve in addition to that office as clerk for the Selectmen, Assessors, Overseers of the Poor and Board of Health, and do the routine work now performed by the Town officials, would be a distinct advantage over the present methods. The need of a finance committee to examine and report on articles in the warrant calling for an appropriation of money has been discussed and urged many times, and the by-law your Committee present for acceptance is drafted after similar ones adopted by other towns. The amount of the salaries of the offices as recommended by your committee will be less than the Town has paid for the past two years, and no increase in the average expense of the past five years. Believing that the changes proposed would result in serving the best interest of all concerned, and for the reasons given above your committee unanimously recommend that the Town vote to accept the sections of Chapter eleven of the Public Statutes as called for, elect the following officers in the manner proposed, appropriate the amounts asked for salaries and adopt the by-law as called for in Article 29 of the Warrant, as follows:

1. That the Town vote to accept sections 335, 338, and 339 of Chapter 11 of the Public Statutes, relating to the election of Town Officers. Said change to go into effect March 3, 1903.
2. That the Town vote to elect a board of Selectmen and Overseers of the Poor consisting of three members, and elect one for the term of one year, one for the term of two years, and one for the term of three years, and at each annual meeting thereafter elect one for the term of three years, as the term of office of one expires, and appropriate \$350 for the same, to be divided as follows: Chairman \$150.; 2 Selectmen at \$100 each.
3. That the Town vote to elect a Board of Assessors, consisting of three members and elect one for the term of one year, one for the term of two years, and one for the term of three years, and at each annual meeting thereafter elect one for the term of three years, as the term of office of one expires, and appropriate \$500 for the same, to be divided as follows: Chairman \$200 – 2 Assessors at \$150 each.
4. That the Town vote to elect a Board of Health consisting of three persons, one of whom shall be a physician who shall serve for terms of one two and three years respectively; beginning with the day following the meeting at which they are elected, or until their

respective successors are chosen and qualified; and thereafter the Town shall at its annual meeting choose one member of such board, who shall hold office for three years from the day following such meeting and until another is chosen and qualified in his stead, and appropriate \$175 for the same, to be divided as follows: Chairman \$75.00 – 2 members of Board of Health at \$50.00 each.

5. That the Town vote to elect a Treasurer and Collector of Taxes and appropriate \$1000.00 for same, and that the Treasurer's bond be furnished by some surety company authorized to do business in this state and to be paid for out of the contingency fund.
6. That the Town vote to elect a Town Clerk for the term of three years, said Clerk to serve as Clerk for the Selectmen, Overseers of the Poor, Assessors and Board of Health, and to devote his entire time to the business of the Town during business hours, and appropriate \$1000.00 for the same.
7. To see if the Town will vote to adopt the following By-Law:
There shall be a Finance Committee consisting of the Chairman of the Board of Selectmen and Overseers of the Poor, Chairman of the Board of Assessors, Chairman of the School Committee, Chairman of the Water Commissioners, Chief of the Fire Department and nine other legal voters, who shall hold no other Town office, and shall be appointed by the five above named officials for the term of one year beginning with the first day of January, and who shall serve without pay. Said Committee shall consider all articles in the warrant calling for an appropriation of money and shall report thereon at the Town meeting. They shall have power to fill vacancies in this Committee.

The following letter was read to the meeting.

My Dear Mr. Hartshorne,

Within a few days I have been informed that your Committee contemplated the erection in the near future, of a school house in the eastern part of Methuen, somewhere near my old home. If this information is correct, I should be pleased to present to my native Town a tract of land containing 20,000 sq. feet, situated just off Merrimac Street in the Pleasant Valley District, and extending from Alton Road to Booth Road, comprising lots nos. 16, 17, 38 and 39, as per plan of survey made by J. A. Latham C.E. of Providence, R.I. in 1897. This land is well situated for school house purposes, being dry and of sufficient elevation to command an extensive view as well as to be thoroughly drained. It is handy to the electric cars, and yet far enough away to be free from noise and danger. A building on this lot would naturally face on Booth Road; the end facing on Alton Road contains a few noble oak trees, which would make a delightfully shady playground for the children in the warm weather. This tract is the last foot of land which I own of my birth place, "The Old Bradley Farm Homestead," – and I have always had in mind its use for school house purposes on account of its desirable situation. If this location is in that part of the district which in the judgment of your Committee requires new school accommodations, I should be pleased in memory of my beloved sister, Elizabeth Bradley who, during her whole life was deeply interested in the welfare of the children of "Pleasant Valley", to present through your Committee to the Town of Methuen, the lots of

land above mentioned; and this is offered without any reservation, except that the land shall be forever used for school house purposes, and that a school building shall be erected thereon within the next five years.

A motion to lay Article 25 upon the table was defeated, Yes 41 No 63, and the motion made by Mr. Oliphant was carried and two thousand dollars appropriated.

Article 9

Fire Department

Voted, that the compensation of members of the Fire Department be the same as last year.

Article 10

Dog taxes

Voted. That the money received from dog licenses, in accordance with Chapter 102 Section 163 of the Revised Laws, be appropriated for the use of the schools.

Article 11

Memorial Day

Voted: - that two hundred dollars be appropriated for the purpose of decorating the graves of our soldiers and sailors on Memorial Day, May 30, 1902, said money to be expended under the direction of the Col. Wm. B. Greene Post 100 G.A.R.

Article 12

Marking Graves Rev. Soldiers

Voted to appropriate the sum of one hundred dollars to assist in marking the graves of Revolutionary Soldiers.

Article 13

Retaining Wall

Voted to build a retaining wall on Railroad Street in front of the property of Elizabeth Ainsworth and John Cunliffe a distance of about 120 feet and appropriate one hundred dollars for the same; to be taken from regular appropriation.

Article 37

French Court Sewer

By request, Article 37 was considered.

Voted, to construct a sewer in French Court, a distance of about two hundred feet, and appropriate two hundred dollars for that purpose.

Article 14 **Macadam Milk Street**

Voted to pass over Article 14 of the Warrant.

Article 15 **Macadam**

Voted to pass over Article 15 of the Warrant.

Article 16 **Macadam**

Voted to pass over Article 16 of the Warrant.

Article 17 **Lowell St.**

Voted to pass over Article 17 of the Warrant.

Articles 43- **Street Lights**

52 Voted that Articles 43 to 52 inclusive, relating to street lights, be referred to the Street Light Committee of last year, it being the committee appointed Sept. 25, 1897. At twenty minutes past five, it was voted to adjourn for one week, to Saturday March 15, at one o'clock p.m.

Record of Adjourned Town Meeting

The Inhabitants of the Town of Methuen qualified to vote in Town affairs met at the Town Hall at one o'clock p.m. according to adjournment, the Moderator in the chair.

Article 18 **Culvert Lowell St.**

Voted to clean out and lower the culvert near the house of Edmund Dowding on Lowell Street, and appropriate fifty dollars for the same.

Article 19 **Culvert East St.**
Voted: - to widen the culvert crossing East Street opposite land of Louis Reuter, and appropriate fifty dollars for the same.

Article 20 **North St.**
Voted to pass over Article 20 of the Warrant.
The number of voters in the hall being small, it was voted to take a recess until two o'clock.
The meeting reassembled at two o'clock and proceeded to the consideration of Article 21 of the Warrant.

Article 21 **William St.**
Voted to repair William Street and appropriate two hundred and fifty dollars for the same, and that the expense be taken from the regular appropriation.

Article 24 **Sewer Loan**
Voted: - by a unanimous vote, that for the purpose of paying for the construction of sewers, the Town Treasurer is hereby authorized and directed to borrow with the approval of the Board of Selectmen, the sum of thirty five thousand dollars and to execute and deliver the notes of the Town therefore, payable as follows: - then thousand dollars in five years from the date of issue and twenty five thousand dollars in thirty years from the date of issue, with interest thereon at the rate of three and one half per cent per annum payable semi-annually.

Article 26 **Street Improvement**
Voted: to appropriate two hundred dollars, for street improvements in the Town of Methuen, the same to be expended under the direction of the Town Improvement Society and Tree Warden.

Article 27 **Boston & Northern St. R.R. Co.**
After considerable discussion of Article 27, Mr. Newsholme moved that the Selectmen be requested to give the Boston & Northern Street Railway Company leave to withdraw their petition for a double track on Broadway to the present turnout on Hampshire St. and the motion was carried.
Voted: - that the Selectmen be instructed to ask the Railroad Company to repair the road from Central Square to Brown Street.

Voted: - that the Selectmen be instructed to refuse to extend the time to the Boston and Northern St. R.R. Co. for the construction of the road from Brown St. to Oakland Ave. and also to the Lawrence and Methuen R.R. Co. for an extension of time to complete their road.

Article 29 **Town Officers**

Voted to pass over Article 29 of the Warrant.

Article 30 **Committee**

The Town voted to adopt the following By-Law.

There shall be a Financial Committee, consisting of the Chairman of the Board of Selectmen and Overseers of the Poor, Chairman of the School Committee, Chairman of the Water Commissioners, Chief of the Fire Department and nine other legal voters who shall hold no other Town office, and who shall be appointed by the Town Meeting for the term of one year, beginning with the first day of January, and who shall serve without pay. Said Committee shall consider all Articles in the warrant calling for an appropriation of money, and shall give at least one public hearing to parties interested before any Town meeting and shall report thereon at the Town Meeting. They shall have the power to fill vacancies in their Committee.

Voted to proceed to the appointment of a committee of nine from the floor. The following persons were appointed: Daniel W. Tenney, James O. Parker, Joseph E. Buswell, Fred Miller, Jacob Emerson, Wm. H. Craven, George B. DeMars, Samuel Emerson and Moses G. Smith.

Article 31 **Summer St.**

Voted: - that the whole subject contained in Article 31 of the Warrant be referred to the Selectmen with power to sell and convey the land owned by the Town situated in the vicinity of Summer St., meaning thereby the lot where the ledge was taken out, and the lot where gravel has been taken.

Article 32 **Water rates**

Voted – that the present water rates be continued. The subject of extending water pipes up Pelham Street was referred to the Water Commissioners.

Article 33 **By-Law**

Voted to adopt the following By-Law.

No member of the Board of Selectmen, Overseers of the Poor, Board of Health, Water Commissioners, School Committee or Highway Surveyor shall be interested in a private capacity either directly or indirectly in any sale, contract or agreement for labor or any materials, goods, wares or merchandise furnished to the Town wherein said Town is a party interested nor shall he directly or indirectly, for himself or any other person receive any commission, discount, bonus, present or reward from the person or persons making such materials, goods, wares or merchandise. Provided, that an exception shall be made to the above By-Law, so as to allow the furnishing of one driving horse when found necessary to facilitate the Town business, and also in the case of a snow blockade, when this By-Law shall not apply.

Article 34 By-Law

Voted: - to repeal Section 2 of the Town By-Laws, and to adopt the following By-Law as Section 2.

The warrant for all Town meetings shall be directed to either of the Constables of the Town, and meetings shall be notified by posting an attested printed copy of the Warrant at the Town House and at some public place in each voting precinct eight days at least before the day of meeting; and whenever a special meeting is called he shall also cause the same to be printed in some newspaper, if there is one printed in the Town, once a week for two successive weeks, the last publication to be not less than one day before the day of meeting.

Article 35 Engine & Boiler

Voted: - to pass over Article 35 of the Warrant.

Article 36 Ledge

Voted to refer Article 36 to the Selectmen, to investigate and report thereon to the next Annual Town Meeting.

Article 38 Watering Place

A motion to pass over Article 38 was lost.

Voted, that the Water Commissioners be requested to place a watering fountain in the Tenney Street Square and that the cost thereof be taken from the water works funds.

Article 39 Sinking Fund

Voted – to appropriate the sum of three thousand five hundred dollars, to be placed in the Sinking Fund.

Article 40 **Sale of land**
Voted – to sell a tract of land on Lowell Street, being a part of the Barker School lot, to George A. Closson to carry out a contract made by him and the School Committee.

Article 41 **Hose**

Voted: - to purchase two hundred feet of hose to be used in connection with the reel now located near Smith's corner, and appropriate eighty dollars for that purpose.

Article 42 **Fred Millar Taxes**

Voted to reimburse Fred Miller the amount of taxes overpaid by him from 1891 to 1899, the same to be charged to the general abatement for 1902.

Articles 43-

52 **Street Lights**
Voted to appropriate three hundred and thirty four dollars for street lights, under Articles 43 to 52 inclusive.

Article 53 Voted to accept Channing Street, as laid out by Selectmen.

Article 54 Voted to accept Oakland Avenue, as laid out & widened by Selectmen.

Article 55 Voted to accept Smith Avenue, as laid out by Selectmen.

Voted – that the salary of the Highway Surveyor be twelve hundred dollars per annum, he to furnish his own driving horse.

At 5-25p.m. the meeting adjourned sine die.

Whereby it was voted to adopt the following By-Law: - No member of the Board of Selectmen, Overseers of the Poor, Board of Health, Water Commissioners, School Committee or Highway Surveyor, shall be interested in a private capacity, either directly or indirectly, in any sale, contract or agreement for labor or any materials, goods, wares or merchandise furnished to the Town wherein said Town is a part interested; nor shall be directly or indirectly for himself or any other person, receive any commission, discount, bonus, present or reward from the person or persons making such sale, contract, or agreement, or furnishing such materials, goods, wares or merchandise. Provided, that an exception shall be made to the above By-Law, so as to allow the furnishing of one driving horse when found necessary to facilitate the Town business, and also in the case of a snow blockade, when this By-Law shall not apply.”

Article 3 Voted, - 160 Yes to 27 Nays, - to rescind the vote which was passed at the adjourned Town Meeting held the 15th day of March instant, under Article 27 of the Warrant, requesting the Selectmen to give the Boston & Northern Street Railroad Company leave to withdraw their petition for a double track on Broadway to the present turn-out on Hampshire Street.

Article 4 Mr. Buckminster moved that the Selectmen be requested to so far comply with the petition of the Boston & Northern Street Railroad Company, as to give said Company the right to lay a double track on Broadway, and leave the question of termination to the Selectmen.

Mr. Holman, moved that the petition be complied with when the following requirements are met.

1st Said Company shall carry working men and working women to and from their work on week days between the hours of five and seven in the morning, and five and seven in the evening, for one half the usual fare.

2nd There shall be only one fare from any point in Methuen to any point in Methuen.

3rd The double track from Brown Street to Oakland Avenue shall be completed and put in operation.

4th That when these conditions are fully met, the Boston and Northern Street Railway Company be granted a location for a double track from Oakland Avenue on Broadway to the southerly side of Osgood street only. The Town reserving the right to allow the use of the tracks by other roads if it should prove for the best interests of the Town. Said company shall pave the usual distance outside the tracks using first quality block paving only. Nothing less than 90 pound rails to be used. Mr. Ackroyd moved an amendment that these conditions terminate at the end of twenty five years.

Mr. George moved that the whole subject be referred to the Selectmen, and the motion was carried by a large vote.

Voted, to adjourn without delay.
